Professional Services - Agency Matrix Business and Agency Matrix Performance

- I. **Overview.** This service agreement includes services for the Customer's initial implementation of the Hosted Application. Additional components, not listed here, require additional services.
- II. **Zywave Team.** The Zywave Team assigned to perform the Professional Services described in the agreement will include a Project Manager, Implementation Consultant, Product Trainer, and Data Analysts.
- III. **Duration.** 10-12 weeks from Initial Effective Date dependent upon customer engagement.
- IV. **Inclusions.** The following services will be provided as part of this agreement.
 - a. Initial Setup:

 - ii. One Administrative User Setup
 - b. Training:
 - i. Access to Zywave University via On Demand and Group Instructor Led curriculum offerings
 - 1. Includes administrative and end-users in English and/or Spanish
 - ii. Unlimited Access to Zywave's Support Library providing:
 - 1. Smart Support Resources and best practices documentation
 - 2. Quick case submission
 - 3. Workflow documentation for end user use
 - 4. Community forum to ask and answer questions
 - c. Data Services:
 - i. As applicable, one-time data import of up to 400GB for currently supported fields via SFTP
 - 1. Customer may request updates to data import for missing or incorrect data within 60 days of the import completion date.
 - d. Consulting:
 - i. Implementation Consulting Services, including best practices and workflow documentation.
- V. **Exclusions.** The following activities are not included in this Agreement and, if applicable, require an additional service agreement and subsequent cost estimate.
 - a. Initial Setup:
 - i. User setup beyond one initial Administrative User Setup
 - ii. Download setup via third party connection
 - b. Training:
 - i. Customized and One on One training and/or materials
 - ii. On-site training or consulting at Customer or Zywave physical locations
 - iii. Creation of custom videos
 - c. Data Services:

- i. Additional data imports or data imports larger than 400GB
- ii. Data import for fields not specified in data template
- iii. Data revisions 60 days after the confirmed import date
- iv. Database backups
 - 1. Raw files accessible for 30 days from initial delivery date to customer.
- d. Consulting:
 - i. Ongoing services including:
 - 1. Custom Accounting
 - 2. Commissions
 - 3. Custom Reports
 - ii. Upload of files and/or attachments
