Exhibit A - Professional Services Description

Professional Services - Sales Cloud - Starter - Full Service

- I. **Overview.** This service agreement includes services for the Customer's initial implementation of the Hosted Application. Additional components, not listed here, require additional services.
- II. **Zywave Team.** The Zywave Team assigned to perform the Professional Services described in the agreement will include a Project Manager, Implementation Consultant, Product Trainer, and Data Analysts, Social Media Specialist, Local SEO Specialist and Website Implementation Consultant.
- III. Duration. Website development 6-8 weeks from Initial Effective Date dependent upon customer engagement.
 Ongoing services available for updating directory listings throughout the duration of the Term. Sales Cloud duration is 4-6 weeks from Initial Effective Date, dependent upon customer engagement.

- v. If a website migration from Legacy IWB, is in scope and in compliance, consultation will be provided to ensure all relevant and compliant content from existing website is migrated over to the new layout. For avoidance of doubt, an in scope and in compliance website migration is limited to existing Zywave website Hosted Applications.
