# Professional Services - Zywave Websites Performance - Premium

- I. **Overview.** This service agreement includes services for the Customer's initial implementation of the Hosted Application. Additional components, not listed here, require additional services.
- II. **Zywave Team.** The Zywave Team assigned to perform the Professional Services described in the agreement shall consist of a Project Coordinator, Website Implementation Consultant, Website Developer, Digital Marketing Specialist, Social Media Specialist, and Local SEO Specialist.
- III. **Duration.** Website development 6-8 weeks from Initial Effective Date based on Customer responsiveness and availability. Digital Marketing Services will be effective once website is live in Production through duration of contract term.
- IV. **Inclusions.** The following services will be provided as part of this agreement.
  - a. Initial Setup:
    - i. Product activation and user setup
  - b. Website Development & Implementation Consulting:
    - i. System configuration for core application functionality
    - ii. System setup includes embedded schema to support search engine optimization (SEO)
      - 1. Google's index is determined solely by Google's algorithms and cannot be guaranteed.
    - iii. Standard features are activated in preparation for site's launch, if applicable.
      - 1. Location Editor
      - 2. Employee Directory
      - 3. Carrier Page
      - 4. Testimonials
      - 5. Quote Forms
      - 6. Mission Statement
      - 7. About Us
      - 8. Create up to fifty (50) carriers, testimonials, and employees
      - 9. Create up to three (3) custom forms with field limit not to exceed 15 fields per form
      - 10. Customize up to ten (10) optimized location landing pages
    - iv. SSL Certificate installation
    - v. Design and development for site layout and navigation based on currently available design themes
      - 1. Request to change the selected design theme during or after development, may incur additional costs.
    - vi. Standard Zywave Website content package
    - vii. Import blogs
      - 1. Requires existing blogs are exportable in XML format from current blog system
    - viii. Complete up to four (4) website reviews with customer prior to site launch
      - 1. Up to four (4) rounds of edits and change requests
    - ix. Site migration options (if applicable)
      - 1. For Zywave website Hosted Applications, a site migration is in scope, and consultation will be provided to ensure all relevant and compliant content from existing site is migrated over to the new layout.

- 2. For non-Zywave website Hosted Applications, migrate up to fifty (50) pages with content provided by customer does not include blog posts.

- ix. Access to Reputation Management Dashboard
- x. Guidance and consultation on setting up and optimizing up to five (5) Google Business Profile pages
  - 1. Optimization and verification subject to Google guidelines
  - 2. Does not include service area businesses such as coworking spaces, PO boxes, remote and virtual office locations

#### d. Custom Content Services:

- i. Delivered by the last day of the month after website launch.
- ii. Includes choice of one (1) custom website page with up to three (3) paragraphs of content, or one (1) custom blog per month up to 400 words.
- iii. Custom Content excludes compliance content and Zywave reserves the right to deny content topics.

### e. Social Media Services:

- i. Weekly Delivery: Social Media post services commence post-website launch, adhering to a standard schedule.
- ii. Facebook Setup & Posts: Platform setup with three (3) posts per week from predefined tracks, featuring curated images from approved media libraries. Posts will include line of business-related content.
  - 1. Note: Customization such as adding phone numbers or agency information is not available due to bulk scheduling.

i. Access to Zywave University via live and on-demand group instructor led curriculum training.

## c. Website Implementation Consulting & Initial Setup:

- i. Unlimited photo download from Media Manager
- ii. Unlimited content migration from existing 3<sup>rd</sup> party platforms
  - 1. Content migration will not exceed 20 pages. Additional page migration will incur additional fees, if the customer wants Zywave to migrate content on their behalf.
- iii. Specific types of custom design, custom development, and integration with 3rd parties such as the following: Logo and other marketing collateral creation or adjustment, API Integrations, website structural adjustments to templates or template parts, etc.
- iv. Customized and optimized location landing pages beyond up to five (5) included
- v. Once Customer agrees to website layout, a Statement of Work will be required for any website layout change(s)
- vi. Layout changes after initial implementation. A Statement of Work will be required for any ongoing layout changes.
